OU's Newest Therapy Equipment

Brain injuries are dynamic, and no two brain injuries present the same. For this fact, brain injuries can be difficult to treat. Our physical, occupational, and speech therapists are constantly looking for proven evidence-based practice interventions to provide the best rehabilitation services to the individuals we serve. Our therapy team identified a piece of equipment called the Dynavision D2 that has been on our wish list for many years due to its proven success with individuals with brain injuries. Opportunities Unlimited, with the assistance of a MRHD grant, was able to purchase a Dynavision D2.

The D2[™] is used to evaluate and train visual, cognitive, and motor function across all ages, stages, and conditions. The D2[™] is utilized in clinical rehabilitation by PT, OT, and ST to address underlying visual, cognitive and motor deficits including visual-motor reaction time, peripheral visual awareness, hand eye coordination, cognitive processing ability, neuro-cognitive abilities, gross motor skills, executive functions, active range-of-motion and dynamic balance, improving their overall functioning with daily tasks. The D2 is highly customizable and can be adjusted to meet individual needs in multiple areas during every step of the rehabilitation process.

OU's therapy team is using the Dynavision with multiple persons served. The team is seeing noticeable improvements in coordination, reaction time, balance, and visual motor skills. However, the most exciting thing we are noticing is the confidence grow in the individuals we serve. The D2 is able to record the score of each intervention, so our persons served are constantly competing against themselves. This allows each individual to use this data to ensure that each day is a little better than the day before and that skills improve daily. These reports allow our individuals to see the progress they are making, that may have gone unnoticed or difficult to identify in the daily tasks they complete. Increased motivation and participation lead to increased results. The D2 is allowing our team and our persons served to realize that all the active treatment and daily work they complete is making a difference in their rehabilitation journey.

Grants Awarded to OU

OU was the recipient of the Variety – The Children's Charity Grant, which supports organizations who provide care and assistance to individuals with special needs. OU received \$12,454 towards the purchase of a new minivan. Considering the number of community-based services provided, a new vehicle was certainly beneficial to provide the needed transportation for our persons served.

OU will receive \$13,000 that will go towards their Gotta Brain Getta Helmet program, which promotes bicycle safety in the Siouxland Community while promoting brain injury awareness. This generous gift will make a direct impact on the youth of our community!

Opportunities Unlimited's President & CEO, Jennifer McCabe, participated in the 2020 Brain Injury Business Practice College January 22-24, 2020 in Palm Harbor, FL. Hosted by the Brain Injury Association of America, this event brought together leaders from around the country who operate facilities caring for those with brain injuries. Some of the topics included working with payor relations, developing neuro rehabilitation offerings, and CARF standards. "As an ICF and RCF provider supporting those affected by brain injury, it was



beneficial to connect with other leaders throughout our country who are facing the same challenges and working to identify the best practices in leading successful organizations," stated McCabe. This is the second time Opportunities Unlimited participated in the Business College, which was just one of two organizations representing brain injury facilities from the state of Iowa.

Hill Day

Persons served and staff of Opportunities Unlimited participated in the 2020 Brain Injury Alliance Hill Day at the Iowa State Capitol on February 5, 2020. This annual event allows brain injury survivors along with their families, supporters, and providers to speak with state legislators about services and legislative requests. Some of the BIAIA's 2020 legislative requests include protecting Iowa youth by requiring helmets while riding mopeds and motorcycles, \$1.2 Million dedicated funding for a stroke and community care program, increase funding for the Medicaid HCBS waiver waiting list, and support efforts for higher wages, training, and a centralized information system for Direct Care Professionals.
